#### 1.3. A brief overview of the institution under evaluation

The Academy "Evolucion" is a private higher education institution in design and applied arts. It was originally established as Fashion Institution "Evolucion" on 14.09.2005, based on Board of Directors' Decision Nr. 01/05. The Academy "Evolucion" is based in Prishtina, "Shefqet Shkupi".

The operation of the Academy "Evolucion" is based on the Law on Higher Education of the Republic of Kosovo, its Statute and other regulations, based on other applicable laws in the Country.

The Academy "Evolucion" has defined the strategy for achieving its mission and objectives. The strategy was drafted by the Board of Directors in co-operation with the management and the heads of the Academy "Evolucion" departments.

The Academy "Evolucion" offers a range of programs at undergraduate - Bachelor level and graduate level — Master level. One of the undergraduate - Bachelor level is Communication Design Program. In all of its bachelor's programs, the "Evolucion" Academy, including the Communication design program, offers the studies at level 6 according to the EQF, with 180 ECTS, finalized by issuing of a corresponding bachelor's degree.

The study program Communication Design has accredited / re-accredited for the time periods: September 2009 - September 2010, September 2010 - September 2013, October 2013 - September 2016, October 2016 - September 2021, October 2021 - September 2022.

As stated in the Self-evaluation Report (SER), the Academy "Evolucion" has been constantly evolving. The Academy "Evolucion" has added new programs and advanced the existing ones, improved the teaching infrastructure and implemented mechanisms to increase the quality of teaching and learning as well as the advancement of academic staff.

During to the years, the number of students has increased. The structure of students is quite diverse. They come from all regions of Kosovo and from neighboring countries (Albania, Northern Macedonia, Montenegro and Preshevo Valley) as well as from diaspora.

#### 2. PROGRAM EVALUATION

The institutional evaluation consists of 7 subheadings through which the administration, organisation and management of the institution, as well as teaching and research are assessed.

In this report the term research includes artistic research, exhibitions and applied research.

#### 2.1. Mission, Objectives and Administration

As it is mentioned in the SER, the mission of the study program is to develop applicable, comprehensive and meaningful creative skills through various approaches to innovation and contemporary technology integrated into visual communication. The mission of the study program is in compliance with the overall mission statement of Academia "Evolucion", which is publicly available on the web page, but the mission of the study program is not public available, it is only statement in the SER. Because of that, it is gained the impression that all stakeholders are not familiar with the mission and it is set by the management team of study program. The mission of the study should be well known to all stakeholders.

Regarding the consistency of the program with the National Qualifications Framework and the Framework for Qualifications of the European Higher Education Area, no evidence-based information was provided in the SER nor during the site visit. No explicit formulations which would connect the proposed learning outcomes of the program to specific level descriptors relevant to the program were provided. It is not clear what means "The program consists of three academic levels (4, 5 and 6)" (page. 32). References levels for this study program under re-accreditation is 6. Also, the learning outcomes for the study program should be written more precisely and should be measurable.

The SER contains very general statements on didactical approaches and research activities Quite often the statements are rather abstract or normative statements without giving information on how they implemented in the study program practically.

Based on the SER, the additional documents from the website and the site visit (meetings with the management of Faculty and professors), considerable information was provided on formal policies, guidelines and regulations dealing with recurring procedural or academic issues. It can be assumed that program topics related to administration and quality assurance of the program, the interaction between teachers and students, rights and duties of all stakeholder are well developed and well-known.

It is gained the impression according to the SER and information gained during the interviews that a good level of compliance with internal regulations relating to ethical conduct in research, teaching and assessments in most of the relevant areas has been achieved so far.

Based on the statement in the SER, the Academy "Evolucion" has established rules, standards, and processes for drafting and approving its programs. The Academy has "Regulation on accepting and monitoring study programs at the Academy "Evolucion", in the SER that document mentioned under the name "Regulation on the Design and Development of Curricula of the Academy" p. 40. In the above mention regulation only article 7 (in the SER mentioned Article 5) deal with procedure of program reviewed. Also, the mentioned document does not have data of the frequency of the study program revision just conclude that "The system of internal quality assurance must contain periodical evaluations of the study programs "

- 1. The study program should strive for a revision of the research concept and integration of research at the program level and strengthening the linkages between teaching and research.
- 2. Also, the study program should be revised and a clear and unitary approach should be taken using the same framework for all disciplines, especially take care of learning outcomes.
- 3. As SER report is a basic document for further internal review and evaluation process, it is recommended that the document be edited to better meet the objectives of the process (some sentences are not completed and clear, some sentences are duplicated even whole paragraphs, incorrect naming of documents etc.)
- 4. To perform a mapping with similar study programmes in other countries in regard to programme structure to ensure that the study programme is compliant with EQF level 6;

#### 2.2. Quality Management

First of all, it should be noted that the terminology used in the chapter 2. Quality Management is not harmonized, it is mentioned assurance committee, assurance council and commission for quality. It is not clear is it one body with different name or different bodies. From the "Organization structure of the Academy Evolucion" page 10, it is concluded that should be one body.

The SER contains a description of how quality management at the Academia Evolucion works and which instruments it contains.

According to the SER, the Academy "Evolucion" controls and develops its own quality assurance system of teaching and creative and artistic activities. The Quality Assurance Regulation is based on the Academy "Evolucion" Statute, Article 100.-102.

The Quality Assurance Regulation, its mechanisms and processes have been drafted with the support of the EU project (QA@PHHEP10), which has supported the establishment and development of quality assurance structures within IAL in Kosovo.

Quality Assurance is the responsibility of the Quality Assurance Office (QA Office), which reports to the Quality Assurance Council (hereinafter: QA Council) and operates under the Quality Assurance Regulation.

This regulation contains QA's rules and procedures, instruments and executive mechanisms as well as QA's organizational structure.

In the SER is statement on the page 12 "The Quality Assurance Council consists of five members;- two members are nominated by the Academic Council,- the other two members are nominated by the Executive Director and- one member represents the Student Council. Members nominated by the Academic Council may come from the ranks of academic staff, research staff, administrative staff, and industry practitioners." But in the Quality Assurance Regulation on the page 2 is statement "The Academy "Evolucion" conducts the Quality Assurance control through the Quality Assurance Committee, which consists of three members: the academic director, the quality assurance officer and of a representative of the lecuters."

Based on the SER, the quality assurance office produces "Quality assurance annual report", the results of the report are reviewed by the Quality Assurance Council. It serves as the basis for further plans for improving and ensuring quality in the Academy. However, the document "Quality assurance annual report – academic year 2020/21" contains only general information about students as are exams pass rate, number of graduates, attendance in the

lectures, and list of the activities and projects. There is no information about the student workload, academic success, and employment of graduates. The report does not include any recommendations.

Based on the SER, the quality assurance office implements the recommendations and carries out the tasks undertaken by the Quality Assurance Committee.

According to the SER, the "Evolucion" carried out regular internal and external evaluations with students, academic staff and administrative staff, but it is not clear do not carry out evaluations with employers and graduates. The quality management tools are a survey/questionnaire and self-evolution by academic staff; the student assessment questionnaires; the analysis of parameters based on work reports and performance of tasks.

Quality Assurance Office has prepared questionnaires for quality assurance for example Questionnaire for beginner students of Bachelor level; Semester questionnaire for Bachelor and Master level students for the evaluation of the teaching process and teachers; Administration / service evaluation questionnaire for students; etc., The SER is the only document where is listed all prepared questionnaires. Even the document "Quality Assurance Regulation" does not have the mentioned questionnaires list. Because of that, it is again an impression that the list of questionnaires was prepared just for the evaluation purpose.

From the available document, it is clear that students, teachers and administrators, are involved in the work of the quality assurance office.

There is no defined procedure which determines how survey stakeholders are informed of the steps taken based on their comments. The results related to the teaching process quality are delivered to the academic staff privately. The results of the conducted surveys should be publicly available as a complete presentation without specifying names.

#### 2.3. Academic Staff

The procedures for the selection and appointment, of academic staff are in line with the criteria stipulated in the Law on Labour and Law on Higher Education. Also, the employment of the academic staff in the Academy "Evolucion" is based on the Statute, the Staff Recruitment Regulation of Academy and the Code of Ethics of the Academy "Evolucion".

Candidates for employment are not provided with full position descriptions and conditions of employment. When the candidate is selected, is provided with a job description.

According to the relevant documents, during the employment, the Academy implements fair, impartial, equal and non-discriminatory treatment in order to prevent discrimination based on race, gender, language, family status, political opinion, ethnicity, disability, age and other legally protected status.

There are mismatches across the data how many academics staff is involved in the study program Communication design.

According to the statement in the SER, for the study program a total of 10 members of academic staff are engaged, "...of which 6 are Full Lecturers (FT), 2 are Non-Regular Lecturers (PT), and Visitor / Consultant" p. 46-48" It is not clear what is it with other 2 academic staff. Also, from the syllabus it is evident that 13 teachers are involved in the program. The role of 7 teachers involved in the study program is not clear, is it full time or part time academic staff. Based on the SER, Arsin Shala is full time academic staff at Akademia Evolution, but according to his CV he is founder and director of "XHAD studio".

The Faculty staff formally consists of lectures with master degrees.

In the tabular presentation of the academic staff data missed information such as the workload for teaching, exams, consulting, administrative activities, and research.

It is not evident from the formal staff profiles (CV submitted prior to the review), is academic staff able to deliver high level student learning experience through inclusive, relevant programmes and curricula while being professional and collaborative. Some CVs are written in Albanian (Besim Hoxha, Vesa Govori-Hapciu), some are illegible (Arta Agani), without information about exhibitions or publications.

Academic staff evaluation is conducted regularly based on the Evaluation of Academic Staff Regulation of Academy Evolucion and Quality Assurance Regulation of the Academy Evolucion. But from available data, it is not clear whether they are implemented, because it is not proved

track (list of projects, list of published works, list of exhibitions, etc.as requested by Evaluation of Academic Staff Regulation)

Also, it is not clear whether self-evaluation, peer and superiors' evaluations occur on a formal basis at least once each year. The aim of teaching observations, peer and superiors' evaluations, is to enable academic staff to gain feedback from their colleagues, who are trained and experienced teachers, as part of a process of reflection on teaching performance.

Also, the impression was gained that are not provided opportunities for additional professional development of teaching staff, because for example the majority of courses do not have well-defined learning outcomes.

#### 2.4. Educational Process Content

Overall, little information was provided about the why and how of the curriculum's structure corresponds to level 6 of the European Qualifications Framework.

The study program has defined 10 learning outcomes, however, the definition of the learning outcomes in the program is not well written and inadequate forms for teaching and learning.

The 1st learning outcomes is not clear and it is not possible to measure them. For example, it should be "The student will be able to integrate different methods of visual communication into design"

The 2nd and 9th is well written.

The 4th learning outcomes for example should be "use/application of software in realization of their creative ideas ..."

Some learning outcomes are quite similar for example the 6th and 7th (6. The student will be able to design and offer brand identity to various local and international clients; 7. The student will be able to design, realize and apply a brand book of a company / institution, based on the identity of the brand (brand) and to develop and manage various marketing plans, applying methods and various Communication Design techniques; )

Student learning outcomes state what students are expected to know or be able to do upon completion of a course or program. At both the course and program level, student learning outcomes should be clear, observable and measurable, and reflect what will be included in the course or program requirements.

Because the learning outcomes are not well written it is not possible to judge is it the study program complies with the National Qualifications Framework

The courses description is available in two documents: in the SER and in the individual course descriptions which are assumed to have been written by teachers.

The data in the above-mentioned documents are not the same, the learning outcomes for the courses are different in the SER from those written in the individual course description. For example: Drawing for Design (Illustration), Photography 3, English Language etc. Some courses description (given in separate file) does not have the full course description, some of

them are written in the Albanian language. Some courses do not have defined learning outcomes at all.

The majority of courses do not have well-defined learning outcomes or that the learning outcomes are not adequate. Some learning outcomes in the minority of courses is characterized by using active verbs for defining learning outcomes at the course level.

In the SER is description of two courses: Professional Practice and Internship with same ECTS amount but different learning outcomes. It is assumed that it is the same course with a different title, but the learning outcomes should be harmonized.

Therefore, is necessary to review all the learning outcomes on all courses and reformulated by using active verbs to become more adequate for the study program.

Furthermore, learning outcomes of the courses should be in line with the study program learning outcomes and also uniform across all courses in the study program, and in all public available documents. A well-written learning outcome will focus on how the student will be able to apply their new knowledge in a real-world context.

Based on the previously mentioned data, one gets the impression that it is not completely clear what are the learning outcomes and what is their meaning, and that teachers are not familiar with learning outcomes.

The program should seek to resolve this issue with different and inadequate written learning outcomes as soon as possible and arrange it according to European standards.

The courses do not have the full course description within the curriculum do not has analytical syllabuses which comprise all necessary data, but the syllabi provided reveal uneven quality levels of course descriptions. This could be improved by making template with clear and explicit explanation of what the course description has to contain.

The courses have listed references, without citing whole data (publisher, year of publishing etc.). Consequently, it can be concluded that the cited literature is not available in the library nor to teachers nor to the students. Therefore, it is necessary to review all the literature, remove inadequate and add new literature in the course descriptions.

The academia assures that the competences and skills of graduates are in accordance with labour market demand through consultation with industry representatives that was confirmed

during the meeting with employers of graduates. Employers of graduates are satisfied with the knowledge and skills of the graduates acquired through the study program.

The curriculum should be aligned with the student workload and the corresponding ECTS. According to some course descriptions, it can be assumed that the student's workload is not adequately assessed.

The teaching method, which is in use, is an interactive method, During the interviews academic staff declared that classes are being conducted in two ways, theoretical lectures and seminars in a smaller group. The academic staff state that the different methods of teaching are being used in order to achieve the learning outcomes of the courses. According to the SER the academy state that they support teaching staff to update their skills in teaching and learning. During the interviews with students, they confirmed that smaller groups are being effective and they are satisfied with this.

The assessment methods of the particular course are pre-defined and stated in to the course syllabus in advance. The assessment activities are designed with accordance of the course content considering the principles of academic integrity. During the interviews students state that course syllabus is available for them via web-page, so that they can get information regarding the course any time. Students highlight that they can submit a complaint with the two days after they are informed about the grades.

The academy has signed few memorandums and contracts with the local organizations to give possibility to students to make internship and practical component. After a student gets possibility to make internship in any of the organization it will be assessed and monitored to include it in the practical component of the program. During the interviews with the program head and faculty management, it was mentioned few times that the practice is something they are going to enhance in the program and due to this fact, some ongoing activities are managed on the faculty level.

#### 2.5. Students

The admission procedure at institutional level it is clear and formal adopted, and publicly available. According to the procedures, all applicants need to submit the portfolio together with the documents pre-defined by the academy. One of the most important assessment criteria is the commitment of the applicant to deepen their knowledge in the field of communication design. All of them should submit the matriculate exam statement together with their CV. Il students stated that they went through those procedures. During the interviews with faculty management and program head it was found out that there is competition in recent year when getting new students. Due to this reason the administration decided to take in to account the students previous learning achievements, plus the grades they get into the entry exam and only after that finalize the list of the accepted students.

During the interviews with student's expert panel tried to find out whether students felt comfortable with the number of the classmates, which they confirmed that the groups are not overloaded.

During the interviews students as well as academic staff stated that they provide feedback to each and every activity that is done with the courses, however the forms and types of the feedback were not defined. Some students mention that lecturers also give general feedback on the commonly made mistakes during the classes. Students are able to submit the compliant within the two days after getting the grades, however, there was not any of the case student can recall. All of the grades are saved in to the information system, make it possible to create analyses and also make a record for individual student. The program offers peer to peer consultations to students who required additional support from the teaching staff, in addition to this, individual study plans are also designed if there is a need of this.

The Academy states that the plagiarism is being checked, however it is unclear which program is used. According to SER the software is being installed and is not fully functioning yet. The expert panel tried to find out whether the software is used in ongoing activities within the courses and not only in the case of the final thesis (if there would be one). As it turned the software is not being used in weekly assignments, moreover there was not any single case/example of detecting plagiarism that any of the academic staff or students can recall. The sanctions are being described in the Code of Ethics but students are not really familiar with that, it is recommended to communicate the procedures and sanctions to students.

Students are familiar with their rights and the way it is regulated. They mention few cases of getting extra support from the teaching staff with consultations and peer to peer meetings, in

general they are very satisfied with the way they are treated both from academic and administrative staff. Although none of the student's panel met was a transfer student, but there is chance of inter university transfer.

The panel was also interested in the career development support students are getting from the academy. As they mention there is a Career Development Center, through with they are getting the announcements of the jobs as well as the have chance to attend trainings in effective interviewing, preparation of the CV and etc.

Almost all the student the panel met wish to have more activities relate to internationalization, both the foreign lecturers and students visiting the academy and the possibility of making mobility. The panels recommend academy enhance the activities with this regard. Moreover, it is important that the academy supports the promotion of teaching foreign language proactively, as stated in SER, the majority of students have problem with the foreign languages.

#### 2.6. Research

The academia Evolucion has the document and "Research Strategic Plan 2022-2027", available on the website. The mentioned document has three objectives, but it is not clear what are the objectives of the research in study program Communication Design.

The objectives supporting actions written very general. As reported in the SER, "...which contains concrete objectives of the research activity of the Academy "Evolucion" together with timelines, necessary financial, logistical and human resources." (p. 125). But, the mentioned document does not have the specified data.

The data about academic staff research and artistic activity and publication productivity could not be found in any available document (website, CV, SER).

The academic staff proven track of quality and quantity of publications/ exhibitions has not record. It is concluded that all academic staff does not satisfy the minimum request of producing the minimum of one scientific/artistic publication per year.

Since it is a study program of Communication design, every member of academic staff should involve themselves in the research/art by having at least exhibition, or work on a joint project with colleagues or students, or publish a scientific and applied research paper.

*In addition, academic staff should publish papers and artistic work under name of the Faculty.* 

Policies establishing intellectual property rights and clear procedures for commercialization of ideas are not provided nor in the any available document, which stipulates that intellectual property rights in any work related to or created by the employee during the employment relationship (during working hours and in the workplace), is counted as the work of the employer and is given the full guarantee of the holder.

According to the SER students are encouraged to participate in research activities through their engagement in individual and group research assignments and projects during their studies. This is mainly an applied research.

#### 2.7. Infrastructure and Resources

Due to the pandemic and epidemiological reasons the expert panel was not able to conduct site visit offline, but the institution submitted all required information regarding the infrastructure and the equipment.

The academia Evolucion is located in five floors building located in Prishtina, has modern infrastructure and offers good study conditions for students and the organization of the academic teaching process. It is not clear if the academia premises is property of the Academy or rent.

The Academy "Evolucion" has offered to the students and staff a range of electronic services for communication and efficient management of teaching and learning processes such as The Electronic Student Management System and the Administrative and Academic Staff (SEMSA) and the official electronic mail of the academy "Evolucion".

The academia space consists of auditorium, ground floor lecture class, studios (drawing, communication design, photography, etc.), library. The above mentioned spaces are equipped with adequate equipment such as computers, scanner, cameras etc.

The above mentioned space is sufficient for conducting of lectures and exercises for study program. The number of seats in the lecture rooms and studios rooms are sufficient for the number of student in lecture/exercise groups. It can be concluded that the institution provides adequate, clean, attractive and well-maintained facilities.

According to the SER, the management of financial resources is the responsibility of the Executive Director with the approval of the Board of Directors regulated in the "The Financial Regulation of Academy Evolucion". Budget planning is done based on the requests of the departments.

The institution presented the financial plan designed for this program delivery. On the basis of the information stated in the SER, it can be concluded that the operation of programe, research and staff development have to rely on student tuition fees, while the biggest expenditure comes to salaries of the staff. There is some amount devoted to library resource development in the budget. The expert panel thinks that the financial planning is missing the risk and the way the institution will overcomes the risks, as it is a guarantee for the processes not to be interrupted. It is advised, the risk management strategy is included in the budget planning of the next 3 years.

The College has its own library with over 557 books for all departments, and not only for the Department of Communication Design. Students and other researchers, academic staff can use the Contemporary Arts Library in Prishtina with over 13 000 titles on the field of Art and Design in Albanian, English and Italian language. (SER p. 129)

As reported in the SER, the Academia has cooperation with the University Library of Kosovo and the Contemporary Arts Library in Prishtina. It is not clear is it the same library or different. Also has cooperation with the National Library of the city of Peja.

The faculty library is open nine hours a week. Students state that they use library often, borrowing some text books.

The students and academic staff have access to the online databases such as: Royal Borough of Kensington and Chelsea, The Architecture open library, Academy of Art University Library etc. However, when asking whether they had used any academic database that might be accessible in the library, no one could name any, in addition to this student cannot remember any academic service library is offering them.

During the interviews student mention that although the infrastructure in the building is quite good, they wish it to be even improved.

#### 3. FINAL RECOMMENDATION OF THE ET

First of all, the Panel is grateful to the Faculty's management and teaching team, its students, graduates and employers for their open and highly constructive contributions to the event, and wishes them well for the future.

Having considered the documentation provided and discussed it with the programme development team, the Reaccreditation Panel recommends the following:

- 1. The self-evaluation report provides a lot of significant information, but to enable proper evaluation, more documents mentioned in the self-report should be attached. Besides the lack of the documents, all attached documents need to be translated into English. and have the same content in all documents. Without these documents and the document with different content for the same things, it is hard to properly evaluate and give recommendations for improvement.
- 2. Regarding evaluation of staff performance, it is suggested that the following criteria are integrated into individual staff records:
  - •Systematic collection of data career progression and feedback from alumni and include their opinion in learning process;
  - Peer observation of teaching as required (with development of appropriate observation criteria);
  - Regular staff appraisal in terms of identifying staff development requirements;
  - Staff membership in the educational and professional bodies;
  - Staff involvement in learning and teaching research initiatives;
  - Participation in learning and teaching events and conferences, the Faculty should develop effective policies for teachers' improvement.
- 3. The Panel detected various discrepancies between the formulation of learning outcomes that led it to conclude that the academy does not have clear and uniform learning outcomes methodology. It is strongly advised to formulate a precise methodology of defining learning outcomes and apply it. Furthermore, organize additional education for the academic staff regarding writing the effective learning outcomes.
- 4. Develop a model to improve the research activity of academic staff with a minimal productivity and for increasing the involvement of students in the research and project work.
