### **1.3. A brief overview of the institution under evaluation**

*UBT was established in Prishtina, Kosovo in 2001 as IEME – Institute for Enterprise Management and Engineering. In October 2004 it was renamed to UBT – University for Business and Technology. UBT College organizes studies in 16 Faculties including the Faculty of Art and Digital Media, which is an integral part of the UBT College HEIPP, and it is not a legally independent entity. UBT offers a range of programs at undergraduate and graduate level.*

*The governance of UBT is regulated by the Statute of the institution. UBT is governed by: UBT Board, Academic Council, President and Steering Committee. Every statutory body has standing and ad-hoc structures, sub-committees and working groups. The Governing Board is collectively responsible for the management and control of affairs of the College and for ensuring that an effective system of internal control and representation is implemented in the institution.*

*Dean of Faculty is responsible for academic management of studies. Faculty is responsible for academic strategy, student examination, teaching and learning, research and development, links with industry, operational and procedural aspects including quality policy implementation.*

*The mission and the objectives of the Undergraduate program in Art and Digital Media at UBT are to prepare students/graduates with critical and analytical skills, problem-solving skills, self-initiative, and theoretical and practice knowledge in professional art practice and in multi-disciplinary areas; to provide comprehensive knowledge that will lead them to become professional artists and art specialist working in a broader scope of contemporary art institutions, film, television, advertising and in broader creative industries.*

*As stated in the SER, the activity at UBT is based on strategic goals and the development and review of Strategy takes into account the educational philosophy, national educational policies and social-economic environment within which graduates will work.*

*The institution has identified several strategic objectives: achieving academic excellence; developing research, innovation and social responsibility; creating a positive working and learning environment; maintaining and increasing internationalization and regional partnerships; partnering with the community.*



## 2. PROGRAM EVALUATION

*The institutional evaluation consists of 7 subheadings through which the administration, organisation and management of the institution, as well as teaching and research are assessed.*

*In this report the term research includes artistic research, exhibitions and applied research.*

### 2.1. Mission, Objectives and Administration

*As it is mentioned in the Self-evaluation Report (SER), the mission of the study program is prepare students/graduates with critical and analytical skills, problem-solving skills, self-initiative, and theoretical and practice knowledge in professional art practice and in multi-disciplinary areas; to provide comprehensive knowledge that will lead them to become professional artists and art specialist working in a broader scope of contemporary art institutions, film, television, advertising and in broader creative industries. The mission of the study program is in compliance with the overall mission statement of UBT, which is publicly available on the web page.*

*Regarding the consistency of the program with the National Qualifications Framework and the Framework for Qualifications of the European Higher Education Area, no evidence-based information was provided in the SER nor during the site visit. No explicit formulations which would connect the proposed learning outcomes of the program to specific level descriptors relevant to the program were provided.*

*It is not clear what is the meaning of statement in the SER "The BA program in Art and Digital Media program is designed to prepare students academically and practically so that upon successful completion they should be able to:" (page 9).*

*During the meeting with the employers of graduates it has been confirmed that they have been participating in regular meetings with the management and that they have been consulted regarding the specific issue connected to the study.*

*The SER contains very general statements on research/exhibitions activities. This cannot replace the description of the particular action that would foster the involvement of students and academic staff in research activities at the program as well as on the course level.*

*Based on the SER, the additional documents from the website and the site visit (meetings with the management of Faculty and professors), considerable information was provided on formal policies, guidelines and regulations dealing with recurring procedural or academic issues. It*



*can be assumed that program topics related to administration and quality assurance of the program, the interaction between teachers and students, rights and duties of all stakeholder are well developed and well-known.*

*It is gained the impression according to the SER and information gained during the interviews that a good level of compliance with internal regulations relating to ethical conduct in research, teaching and assessments in most of the relevant areas has been achieved so far.*

*Based on the SER, all policies, regulations, terms of reference and statements of responsibility relating to the management and delivery of the program are reviewed at least once every two years and amended as required due to the changing circumstances. However, on the Faculty web page <https://www.ubt-uni.net/en/study/bachelor-programs/art-and-digital-media/staff/> only basic contact information regarding the academic staff is available. It should be updated by adding teaching and scientific/artist information.*

**ET recommendations:**

- 1. The study program should strive for a revision of the research concept and integration of research at the program level and strengthening the linkages between teaching and research.*
- 2. Also, the study program should be revised and a clear and unitary approach should be taken using the same framework for all disciplines, especially take care of learning outcomes.*
- 3. As SER report is a basic document for further internal review and evaluation process, it is recommended that the document be edited to better meet the objectives of the process (some sentences are not completed and clear, specify page numbers, match the name of the program: Digital Art and Media or Art and Digital Media etc.)*





## 2.2. Quality Management

*The SER contains a description of how quality management at the UBT College and Faculty works and which instruments it contains.*

*The Faculty has a designated Quality Assurance Officer and Quality Assurance Sub-Committee that work in conjunction with UBT Quality Assurance Committee and Quality Manager.*

*Based on the SER, the Faculty has its own internal Quality Assurance Manual which is based on UBT Quality Manual. The main and only one available document (on website) is UBT Quality Manual, from October 2020. The Faculty Quality Assurance Manual was not publicly available on the website.*

*The Faculty of Arts and Digital Media is not mentioned in the UBT Quality Manual (Curricula offered pp. 4, Quality circle pp.5).*

*From the available document, UBT Quality Manual, it is clear that students, teachers, administrators, and external stakeholders are involved in the work of the quality assurance office.*

*The main quality management tool is a survey/questionnaire.*

*The UBT carried out the regular internal and external evaluations with students, academic staff, administrative staff, employers and graduates. As mentioned in UBT Quality Manual the evaluations are foreseen to be conducted on a regular basis: per semester or per academic year; once per semester for students and once per year for all other important stakeholders (academic and administrative staff, graduates, employers).*

*The Faculty conducts a number of surveys and has defined procedures for dealing with survey results. All results collected through surveys and questionnaires are stored in the institutional database. There is no defined procedure which determines how survey stakeholders are informed of the steps taken based on their comments. The results related to the teaching process quality are delivered to the academic staff privately. The results of the conducted surveys should be publicly available as a complete presentation without specifying names.*

*From the available documents, it is concluded results of the internal quality assurance system are taken into account for further development of the study program. This includes evaluation results, investigation of the student workload, academic success, and employment of graduates.*

- 1. Make clear what changes have been brought about by evaluation results. Ensure students receive feedback on measures implemented based on their comments*
- 2. Establish internal mechanisms for monitoring the quality of scientific/research or artistic work that will be effectively implemented in practice.*
- 3. Improve surveys and questionnaires for all groups of stakeholders by addressing the learning outcomes.*



### 2.3. Academic Staff

*The procedures for the selection, appointment, evaluation and development of academic staff are in line with the criteria stipulated in the Law on Labor and Law on Higher Education.*

*The rights and responsibilities, recruitment processes, supervision, performance evaluation, promotion, support processes are included in the "Regulation on Labor Relations and Responsibilities for Working Duties" 2019 and the "Statute of the UBT College HEI"-2018, under the Article 72. Also, the fair and transparent criteria for staff selection, appraisal and development are outlined in the Quality Manual.*

*According to the statement in the SER, for the study program a total of 23 members of academic staff are engaged. Also, from tabular presentation of data of the academic staff their role in the study program is not clear, is it full time or part time academic/artistic staff. Later, in the SER it is noticed that all teachers are full time and verified with the e-Accreditation System operated by the Kosovo Accreditation Agency. The Faculty staff formally consists of teachers and lectures with PhD degrees, MSc and MA degrees.*

*It is evident from the Panel discussion as well as formal staff profiles (CV submitted prior to the review), that academic staff is able to deliver high level student learning experience through inclusive, relevant programmes and curricula while being professional and collaborative.*

*Academic staff evaluation is conducted regularly by students, but from available data, the documentation and the panel discussion, it is not clear whether they are implemented. Also, it is not clear whether self-evaluation, peer and superiors' evaluations occur on a formal basis at least once each year. The aim of teaching observations, peer and superiors' evaluations, is to enable academic staff to gain feedback from their colleagues, who are trained and experienced teachers, as part of a process of reflection on teaching performance.*

*The impression was gained that all employees are not aware of all their duties. The responsibilities and duties of staff, which all staff agree, are regular teaching, material design, and student consultations.*

**ET recommendations:**

1. *Continue evaluating and improving the standards of quality of teaching and learning.*
2. *Implement self-evaluation, peer and superiors' evaluations for the teachers.*
3. *Motivate academic staff to achieve the goals defined in the strategy related to research and teaching.*
4. *Organize additional education for the academic staff regarding writing the effective learning outcomes.*



## 2.4. Educational Process Content

*The study program complies with the level 6 of the National Qualifications Framework and with the Framework for Qualifications of the European Higher Education Area.*

*The Faculty assures that the competences and skills of graduates are in accordance with labour market demand through consultation with industry representatives that was confirmed during the meeting with employers of graduates. Employers of graduates are satisfied with the knowledge and skills of the graduates acquired through the study program.*

*The subjects within the study program are well harmonized with the needs of the labour market and comparable to similar programs offered in the region and beyond.*

*The curriculum covers a broad range of qualifications required to work in local or regional companies, professional firms in the field.*

*According to the SER, on the page 10 and 11, is table "Knowledge and Understanding" and "Generic and Graduate Skills". It is not clear on what the listed learning outcomes refers. Later, in the SER on the page 37 at the study program level are defined seven learning outcomes.*

*The courses have the full course description within the curriculum has analytical syllabuses which comprise all necessary data, but the syllabi provided reveal uneven quality levels of course descriptions. This could be improved by making template with clear and explicit explanation of what the course description has to contain.*

*The majority of courses do not have well-defined learning outcomes or that the learning outcomes are not adequate. Some learning outcomes in the minority of courses is characterized by using active verbs for defining learning outcomes at the course level. Some sources do not have defined learning outcomes at all (e.g. Sculpture, 3D Modelling and Animation...) some are written in Albanian. If the course has versions such as courses Art Theory I, Art Theory II, Art Theory III, the learning outcomes cannot be the same for all of them. Therefore, is necessary to review all the learning outcomes on all courses and reformulated by using active verbs to become more adequate for the study program.*

*Furthermore, learning outcomes of the courses should be in line with the study program learning outcomes and also uniform across all courses in the study program. A well-written learning outcome will focus on how the student will be able to apply their new knowledge in a real-world context.*

*Some courses have listed reference, relatively old and not cited with whole data (publisher, year of publishing etc.). Consequently, it can be concluded that the cited literature is not available in the library nor to teachers nor to the students. Therefore, it is necessary to review all the literature, remove the old and inadequate and add new literature in the course descriptions*

*The curriculum should be aligned with the student workload and the corresponding ECTS. According to some course descriptions, it can be assumed that the student's workload is not adequately assessed.*

*The teaching method, which is in use, is an interactive method, where the student conducts different various projects for different subjects, as well as field research works required for this level of study. The teaching strategy is presented in a rather normative way without giving information on how it is implemented in the study program practically. Further information on how an important concept such as student-centred learning is implemented was not provided.*

*The students are given ECTS credits for "Visiting artists and lectures 1-6" but the learning outcomes are not defined as well as other student's obligations. The program should seek to resolve this issue as soon as possible and arrange it according to European standards.*

*The Faculty has appropriate and valid mechanisms for verifying standards of student achievement which are also clearly communicated to students at the beginning of every course.*

*The admission procedure at institutional level it is clear and formal adopted, and publicly available for all UBT programs.*

*But, according to the SER statement “Based on the results of the entrance examination, the Commission creates a ranking list determining which candidates have become entitled to enrol on the basis of the results achieved in the entrance examination and who have psychophysical abilities for the title of Art and Digital Media.” It is not clear what is “psychophysical abilities”. Furthermore, during site visit it was said that prospective students must submit a portfolio. On the web page <https://www.ubt-uni.net/en/study/bachelor-programs/art-and-digital-media/admission/> it is statement “Portfolios (works in different media, writing, design, cultural and social initiatives / activities)”*

*Therefore, the admission procedure for the study program Art and Digital Media it is publicly available but not clear. It is necessary to more precisely define what a portfolio should include and how it will be scored.*

*Almost all rights and obligations of students are publicly available through different document as the Statue, Student Organization Status, Code of Ethics, Handbook for Students, Regulation for Student Assessment, Academic Calendar. All above mentioned documents are available on the main website of UBT College.*

*On the website site <https://www.ubt-uni.net/en/study/current-students/> the title “Study Rules and Policies” one cannot find any description or document in English. On the website <https://www.ubt-uni.net/sq/ubt/per-ubt/politikat-rregulloret/> one can find the document in Albanian: Rregullorja për regjistrimin e studenteve (Regulation of student enrolment) Rregullorja për ciklin e parë të studimeve (Regulation of the first phase of studies) and Rregullorja për ciklin e dytë të studimeve (Regulation of the second phase of studies).*



*The students' transfer between higher education institutions, faculties and study programs is clearly explained in the SER. On the website <https://www.ubt-uni.net/en/ubt-en/about-ubt/regulations-and-policies/> one can find title "Regulation of transfer from one academic institution to another" but it is not publicly available.*

*UBT College is dedicated to supporting ethical behaviour, therefore the submitted written works or final student's papers have adequate check for plagiarism through software "Turnitin".*

## 2.6. Research

*The College has the documents “Revised UBT Strategy 2027” and “Academic Strategic Plan 2020-2025” (without the date of acceptance and the body that accepted it), “UBT Research Strategy” (without the date of acceptance and the body that accepted it). All of above mentioned documents are available on the website. But none of the mentioned documents makes it clear what are the objectives of the research in study program Art and Digital Media.*

*UBT College publishes the Journal “International Journal of Business and Technology” (<https://knowledgecenter.ubt-uni.net/ijbte/>). This is an interdisciplinary peer reviewed journal that enables the publication of research in various fields. As a positive, it should be noted that the journal has the international editorial board and a blind review of papers, but on the other hand, in the journal there are no published papers in the field of art and digital media.*

*Research and artistic activity and publication productivity varies among academic staff. The part of them has a proven track record with a high quality and quantity of publications, the other part has not. It is concluded that all academic staff does not satisfy the minimum request of producing the minimum of one scientific/artistic publication per year. (6.7)*

*Since it is a study program of Art and Digital Media, every member of academic staff should involve themselves in the research/art by having at least exhibition, or work on a joint project with colleagues or students, or publish a scientific and applied research paper.*

*In addition, academic staff should publish papers and artistic work under name of the Faculty.*

*Policies establishing intellectual property rights and clear procedures for commercialization of ideas are not provided in the contract with academic staff or another document, which stipulates that intellectual property rights in any work related to or created by the employee during the employment relationship (during working hours and in the workplace), is counted as the work of the employer and is given the full guarantee of the holder. (6.10)*

*According to the SER students are encouraged to participate in research activities through their engagement in individual and group research assignments and projects during their studies. This is mainly an applied research. UBT plans involving students in the implementation of research projects, together with staff, which is not the case now. (6.11)*

6. *Stimulate students and researchers to apply for the independent research grant and funds from the external funding, donors and projects.*
7. *Stimulate researchers/professors to published in the “International Journal of Business and Technology”*





## **2.7. Infrastructure and Resources**

*The UBT College is located in a newly building, has modern infrastructure and offers good study conditions for students and the organization of the academic teaching process. UBT College premises are property of College.*

*UBT has developed a platform the Knowledge Centre which, besides serving to students, also serves to the community and other stakeholders for the publication, preservation and management of scientific papers and other projects that are developed within the academic community, staff and students in general.*

*The UBT College space consists of amphitheatre, classrooms, studios, laboratories, library, reading hall. The UBT College has several classrooms, and one of them, the biggest amphitheatre is 665 m<sup>2</sup>. The facilities of UBT College have lecture halls and laboratories equipped with adequate equipment such as video conference sound system, computers, scanner, etc.*

*The above mentioned space is sufficient for conducting of lectures and exercises for study program. The number of seats in the lecture rooms and seminar rooms are sufficient for the number of student in lecture/exercise groups. It can be concluded that the institution provides adequate, clean, attractive and well-maintained facilities.*

*In accordance with the provisions of the Statute, UBT College provides financial resources from the different sources for example from tuition fees, and other payments made by students; grants and payments from research and scientific work, donations, revenues from the development and implementation of projects, etc.*

*The investors capital investment provided infrastructure development.*

*The operation of programmes, research and staff development have to rely on student tuition fees. Also, the College operates several fee-based professional certifications with international vocational training bodies which have proven to be a small but steady stream of incomes.*

*The College has its own library. As reported in the SER the library has sufficient number of books and learning materials in Albanian and English. Students and other researchers, academic staff also have access to the electronic resources through online library, where students and academic staff have access to online libraries such as: EBSCO host, J-Store, Sage journals etc.*



According to the video “Art and Digital Media Infrastructure2022.mp4”, the facility has not electric stairs or elevators and the relevant infrastructure for students with special needs.

### 3. FINAL RECOMMENDATION OF THE ET

*First of all, the Panel is grateful to the Faculty's management and teaching team, its students, graduates and employers for their open and highly constructive contributions to the event, and wishes them well for the future.*

*The Panel is very pleased with the level of optimism and positive atmosphere among all interviewed groups. The communication between the students and the management seems to be very open and on an admirable level.*

*Having considered the documentation provided and discussed it with the programme development team, the Reaccreditation Panel recommends the following:*

1. *The self-evaluation report provides a lot of significant information, but to enable proper evaluation, more documents mentioned in the self-report should be attached. Besides the lack of the documents, all attached documents need to be translated into English. Without these documents, it is hard to properly evaluate and give recommendations for improvement.*
2. *Regarding evaluation of staff performance, it is suggested that the following criteria are integrated into individual staff records:*
  - *Systematic collection of data career progression and feedback from alumni and include their opinion in learning process;*
  - *Peer observation of teaching as required (with development of appropriate observation criteria);*
  - *Regular staff appraisal in terms of identifying staff development requirements;*
  - *Staff membership in the educational and professional bodies;*
  - *Staff involvement in learning and teaching research initiatives;*
  - *Participation in learning and teaching events and conferences, the Faculty should develop effective policies for teachers' improvement.*
3. *The Panel detected various discrepancies between the formulation of learning outcomes that led it to conclude that the Faculty does not have clear and uniform learning outcomes methodology. It is strongly advised to formulate a precise methodology of defining learning outcomes and apply it. Furthermore, organize additional education for the academic staff regarding writing the effective learning outcomes.*



4. *Increase the visibility of academic staff by improving their profile information on the official faculty web page.*
5. *Develop a model to improve the research activity of academic staff with a minimal productivity and for increasing the involvement of students in the research and project work.*
6. *The Faculty has developed quality policy and procedures that include regular collection and analyses of relevant data with the purpose of ensuring and improving the quality of all institutional activities, especially student participation. Nevertheless, there is room for improvement, especially in quality improvement eg. standardization of syllabuses.*
