## 1.3. A brief overview of the institution under evaluation

Haxhi Zeka University in Peja is an institution of higher education and scientific research, a public institution that accepts students of all nationalities, genders, languages, religions and political beliefs, based on merit and ability. It is a university that offers qualifications in five faculties, in two cycles of higher education, undergraduate and postgraduate. The five faculties

of UNHZ are: Faculty of Business; Faculty of Tourism, Hospitality and Environment; Faculty of Law; Faculty of Arts and Faculty of Agribusiness. Haxhi Zeka University is the successor to the Faculty of Applied Sciences in Business (FSHAB) in Peja, which was founded in 1960 by the decision of the Executive Council of KSAK as the Higher School of Economics and Trade in Peja. In the beginning, the school had only a commercial section in the company and a small number of teachers. In the first year of study 1960/61. 120 students are enrolled. Since then, the school has been training professional economic staff that corresponded to socio-economic conditions. The activity and development of the College of Economics has always been oriented towards the construction of this type of regular study programs that would form economists with modern education who will meet the needs of economic development and business in general. Thousands of economists have graduated from the College of Economics in Kosovo and other ethnic Albanian countries (Macedonia, Montenegro, Serbia, etc.).

This number of economist's best expresses the contribution of the school that gave to the economy of Kosovo and to all Albanian lands. The Higher School of Economics in Peja experienced some very interesting and important existential periods of time. These periods can be divided as follows: 1960-1974 – period of formation and creation of institutional identity 1975-1990 - period of affirmation of the School in Kosovo and in all other countries around Kosovo, 1991-1999 - period of survival, through continuity of the parallel organization of teaching in private homes 2000 - 2006 - the period of reorganization of FSHAB.

The Faculty of Management in Tourism, Hospitality and Environmental (FMTHE) is the successor of the department: Tourism and Hospitality Management (1969-1975), which was part of the Higher School of Economics. This school was established in 1960, as a two-year institution of higher education. In the academic year 2001/2002, the Higher School of Economics was reformed according of Bologna Declaration model and in the same year the Senate of the University of Prishtina approved the curricula according to this declaration for the bachelor level. This School was renamed the School of Business and then the Faculty of Applied Business Sciences. In the same period 2001/2002, the Department of Management in Tourism and Hospitality was reopened, which continues to function today as a Faculty itself. The Faculty of Management in Tourism, Hospitality and Environment of the Public University "Haxhi Zeka" in Peja (PUP), is the bearer of basic and other studies defined by the Law on Higher Education and the Statute of PUP.



Regular and correspondence studies at FMTHM, in Peja are organized in two languages, Albanian and Bosnian, to obtain the academic preparation Bachelor and Master of Science. FMTHE has a full staff of 12 full-time teachers and operates with the following capacities: 1263 students of which 184 are active, with a general administration and complete and ready for work, equipped teaching rooms, with temporary structures created and with well-designed programs for teaching and learning.

## 2. PROGRAM EVALUATION

### 2.1. Mission, Objectives and Administration

The institutional evaluation consists of 7 subheadings through which the administration, organisation and management of the institution, as well as teaching and research are assessed.

The mission of the faculty is to train competitive students for the labor market, in various sectors of the tourism and environmental industries, so that the development of this industry affects the economic development of the country and the overall development of society and the region. The faculty aims to have a leading role in the development of education related to the reform of management in tourism, hospitality and environmental protection, development of local tourism product and management of strategic projects for tourism development, scientific and professional training for management and development of each product resort and hotel and environmental management at home and abroad. The entire teaching and research activity that takes place in the faculty is based on the highest standards in the process

They are in line with the skills and competences listed in Level 6 of the National Qualifications Framework and the Qualifications Framework of the European Higher Education Area.

For all issues of essential and academic procedures that need to be addressed continuously, the bodies of UHZ and the Faculty in MTHM has developed guidelines, policies and regulations for the following issues

The program of Management in Tourism in Bosnian language, constitutes a qualitative achievement for academic objectives at the Faculty of Management in Tourism, Hospitality and Environment will continue the academic tradition by preparing a competitive student for the job market, a future leader in the fields of tourism, hospitality and environment management, who will contribute to the overall development of society and the region.

**2.2. Quality Management**

The University gives priority for the quality issues and the program undertakes to develop the culture and practices applied for efficient quality assurance and management. This area of assessment focuses on policies, organization and quality assurance of teaching, learning, assessment and research. It also covers learning outcomes, their assessment, dissemination and transfer. The mission is to achieve the goals of excellence, equality, transparency and efficiency. Quality assurance is based on internal and external quality assurance as explanatory self-assessment processes.



UHZ has consistently conducted student evaluations of academic staff. Whereas since 2019, the implementation of other questionnaires has started, such as the self-assessment of the academic staff, which is carried out every year, and the results obtained from the self-assessment are used to improve the quality; questionnaires with graduates, questionnaires with employers, student questionnaire administration and dean teacher. All in FMTHE staff participates in these evaluations

The Deans of the Faculties ensure that there are appropriate conditions for the implementation of evaluation activities within the quality assurance system of the academic unit while the Quality and Evaluation Officers in the academic units of the university implement the activities foreseen in the calendar of assurance activities and are supported continuously by office. In accordance with the statutory provisions and other documents, so far the regular activities of the Quality Assurance Office through the coordinators of the academic units. Program planning is derived from feedback received from employers and graduates through the Advisory Bodies' suggestions, as well as quality assessment is derived from inputs from internal evaluation questionnaires such as student questionnaires and the results are published on the academic unit's website.

**2.4. Educational Process Content**

During the interviews with academic staff it was declared that they use different teaching methods in order to achieve the learning outcomes with their students. The majority of the staff mention that due to the small number of the students in this program it is much easier to manage different teaching methods like active learning, problem based learning and blended learning. The expert panel double checked this with students to find out their feelings with existing teaching methods and found out that the students are satisfied with the variety of learning strategies they have within the program.

As students explained all of the course syllabuses are accessible for them in the Learning Management System before and during taking the course. The assessment methods in each course is defined in the syllabus. The expert panel addressed to academic staff to find out how they assess the learning achievements, as it turned out it differs from course to course, but mostly quizzes (with open ended questions) and oral presentations are used. After each assessment activity, there is a consultation hour where students are given feedback about their grades. If student is unsatisfied with the grade, they can appeal within the 48 hours after being informed about the grades. The expert panel asked students if there was any case of appealing during their studies, as it was said there was none, because all the questions are being answered during the consultations with professors and they do not have any misunderstanding.

According to the SER and the interviews with program heads and students, there is a rule of converting hours spent on internship into ECTS credits. In addition to this, students have to fill the forms prior and after their internships, that has to be signed by the supervisor from the organization



they conducted their practical assignment. As this study program is oriented on the practical skills as well, there are several governmental and non-governmental organizations the program has an agreement. During the site visit expert panel conducted meeting with them, as it turned out due to the program uniqueness (as this is only one study program in Kosovo in Bosnian) there is a demand on their alumni.

## 2.5. Students

According to the institutional rules all applicants who have graduated from the secondary school can apply for the study program. The institution defines additional entrance criteria. All of the applicants need to pass the matriculate exam, based on these scores the final list of the successful applicants is designed. Before they sign the contract and start studying they need to present several documents at the university, among which is the high school diploma.

As the number of the student sin this study program is not much (only 30 students) there is no problem with formation of the groups. As it was stated during the interviews there are sufficient number of the student in both mandatory and elective courses, this helps teachers to design an interactive activity to enhance the teaching and learning process.

As for the exams, usually they are being conducted either in the middle of the semester as a mid-term or by the end of semester. In some cases, there are combined exams – simultaneously in several subjects. Students are informed well in advance about the date and the form of exam. After grading students papers academic staff is hosting consultations where they provide individual feedback to students. If students do not agree on the assessment they can submit written objection to the Dean within the 48 hours after being notified the results. All of the grades are saved in to the information system, make it possible to create analyses and also make a record for individual student. The program offers peer to peer consultations to students who required additional support from the teaching staff, in addition to this, individual study plans are also designed if there is a need of this. During the interviews with academic staff it was stated that the plagiarism is being checked in the Bachelor thesis. The expert panel tried to find our whether the software is used in ongoing activities within the courses and not only in thesis. As it turned the practice of using the software in weekly assignments is not that enhanced, moreover there was not any single case/example of detecting plagiarism that any of the academic staff or student can recall. The sanctions are being described in the Code of Ethics but students are not well familiar with that, it is recommended to communicate the procedures and sanctions to students.



Students are familiar with their rights and the way it is regulated. They mention few cases of getting extra support from the teaching staff with consultations and peer to peer meetings, in general they are very satisfied with the way they are treated both from academic and administrative staff. Although none of the student's panel met was a transfer student, but there is chance of inter university transfer.

One of the challenges that students mention during the interviews is not having a dormitory, and due to the program uniqueness, there are some students coming from the neighbouring countries, for this reason student's dormitory might be a solution. Some students also mention the lower possibility of making mobilities in EU universities, this might get improved as well.

**2.6. Research**



The University has drafted the Regulation of Scientific Research. This regulation defines the rules, procedures and other supporting documents for the organization of scientific research activities of academic staff, researchers and students. The Research Regulation requires each academic staff to publish an average of one paper per year.

In order to manage and support research activities, the University has established a Commission for Research and Science consisting of:

- Vice Rector for Teaching, Science and Student Affairs (Chairman),
- Three Academic Staff with the title of Assistant Professor and above,
- A student representative delegated by the Student Parliament
- Research Support Officer.

Research is one of the main pillars of the UASF Strategic Plan 2018-2020, and Strategic Plan 2021-2026 which is in the process of drafting. This plan includes the spectrum and quality of research and laboratory work at UASF involving both staff and students and in particular those of postgraduate studies.

In the last three years the MSc program academic staff in Management and Innovation in Tourism have published 116 papers in journals and many papers in international conferences presented.

**2.7. Infrastructure and Resources**

Due to the pandemic the expert panel was not able to conduct site visit offline, but the institution submitted all required information regarding the infrastructure and the equipment. As stated in SER there is enough technical equipment as well as a physical space at the Faculty of Tourism to deliver this program with maxim of 30 students in each year. The techniques, books and other



material resources are up to dated and the faculty management state that they will have the same practice.

The institution presented the financial plan designed for this program delivery, stating that getting thirty students annually means they will get funds from the Ministry of Education and Sciences. The financial document is based on this income, while the biggest expenditure comes to salaries of the staff. There is some amount devoted to library resource development in the budget. The expert panel thinks that the financial planning is missing the risks and the way the institution will overcome to them, as it is a guarantee for the processes not to be interrupted. It is advised, the risk management strategy is included in the budget planning of the next 3 years.

According to the SER, the institution presented the calculation of physical space required for thirty students. Students state that they use library often, borrowing some text books. In addition to this, they mention that in some course's teachers are providing the power point presentation adapted for them from the mandatory literature. Expert panel also asked whether students had used any academic database that might be accessible in the library, no one could name any, in addition to this student cannot remember any academic service library is offering them. It is recommended that library design a training session for students (in information seeking, referencing, etc.) and also promote the usage of academic databases widely.

The institution claims that the infrastructure is currently adapted to students with special needs.
