Description

The quality of management within the higher education institution (HEI) system is assessed through the effectiveness of its alignment with The Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG). These standards are designed to be universally applicable to all types of HEIs, regardless of their specialization, location, or mode of program delivery. It falls upon institutions to develop specific internal quality systems, policies, and processes that are robust and continuously enhanced, verified through regular external evaluations.

Given the unique characteristics of each institution, it is anticipated that these internal systems are tailored to suit their individual strategies, operational methods, and environments, thus varying between institutions. They should be customized to attract diverse student segments who will fulfill the qualifications required in the future job market and/or address broader societal needs. Therefore, institutions should formulate their strategic approaches while considering both the institutional and national contexts within which they operate. Their successful achievement depends on the consistent implementation of quality assurance policies across all operational areas and levels of the institution, engaging both internal and external stakeholders in the process. Their future relies on fostering a culture of quality and innovating systems.

The focal point of this conference will be the best practices in achieving quality through the consistent determination and implementation of activities aligned with a predetermined strategy. We will explore the role of strategic management in HEIs in shaping the direction of all system components and stakeholders, and examine how to achieve differentiation and excellence that equally serves the institution and its students, while meeting quality standards and advancing society as a whole.
