1.3. A brief overview of the institution and program under evaluation

The Faculty of Agriculture was founded on August 26, 1973. The aim of this foundation has been the faster development of the agricultural sector in Kosovo by graduating well educated people with superior qualifications in agriculture. By decision of the Senate of University in Prishtina in 1996, the veterinary section was established with the aim of educating professionals in veterinary medicine that would serve animal health, food industry, food security and food safety in general. In 2001, the Senate of the University of Prishtina (UP)

approved curricula based on the Bologna Declaration for Bachelor Degree. In 2006 the Faculty Council and its academic staff pro-posed expanding the Faculty of Agriculture to the Faculty of Agriculture and Veterinary (FAV). The proposal became approved by the Senate of the UP and subsequently the Minister of Education, Science and Technology issued an amending Decision no. 883/01-B, on December 2006. The building of Faculty of Agriculture and Veterinary is located in the suburb area of Pristina, Fushë-Kosovo road, close to the high school for Agriculture and Economics. Classes are currently being temporarily relocated to the building of a secondary school, as the former building is being converted for other purposes and the new building is not yet ready for occupancy. In 2023 a total of 2239 students (BSc and MSc) graduated according to the report of the Student Services of FAV. Fifty docents and teaching assistants are employed on full time basis, supported by 38 additional academic staff members from other faculties within University of Prishtina and other public universities of Kosovo.

The program under evaluation for reaccreditation is a 2-year M.Sc. study program with 120 ECTS that has started in the academic year 2018/2019. This program enables students to gain an advanced knowledge base and practices in the field of Food Science (FS). The number of students for 2022-2023 was 82.

2.2. Quality management

Standard 2.1. All staff participate in self-evaluations and cooperate with reporting and improvement processes in their sphere of activity.	A
The SER states that The Department of Food Technology with Biotechnology holds regular meetings at certain times each semester and each academic staff reports to the department on the progress of implementing the topics of the course syllabus and when the need arises, discussing topics related to the academic work of the department.	
An example of the teaching staff questionnaire should be presented to the ET.	
Standard 2.2. Evaluation processes and planning for improvement are integrated into normal planning processes.	A
The FAV has established an Office for Quality Assurance (OFQA) for structured improvement procedures in line with the legal framework such as the Law on Higher Education, the Administrative Instruction on the Accreditation of Higher Education Institutions in Kosovo and the European Standards and Guidelines (ESG). There is an assessment procedure on course level based on electronic questionnaires that students are required to complete as a prerequisite for taking the exam. Teaching staff has access to the results, gives feedback to the students and improves the courses accordingly. The dean intervenes in problem cases. A further element of the evaluation process is the self-evaluation of teaching staff members. An example of the students' questionnaire should be provided to the ET.	
Standard 2.3. Quality assurance processes deal with all aspects of program planning and delivery, including services and resources provided by other parts of the institution.	В
The SER states that the department continuously supports quality development through program planning, but it fails to described how this is done.

At the meeting with the OFQA, it emerged that the office has only one full-time staff member at UP level, who is supported by teaching staff at FAV level who carry out this task as a limited additional activity beside teaching. The performance capacity of quality assurance is limited accordingly.	
Standard 2.4. Quality evaluations provide an overview of quality issues for the overall program as well as of different components within it; the evaluations consider inputs, processes and outputs, with particular attention given to learning outcomes for students.	В
The SER states that the output of quality evaluations is constantly integrated. No specific information is provided how learning outcomes of students is given attention.	
Standard 2.5. Quality assurance processes ensure both that required standards are met and that there is continuing improvement in performance.	В
Although it is stated that the Food Technology with biotechnology department in each reaccreditation has achieved its objectives and has respected the suggestions of international quality assurance experts there are no examples presented. It would be beneficial t include a few examples in the SER	
Standard 2.6. Survey data is being collected from students, graduates and employers; the results of these evaluations are made publicly available.	В
Survey data from students and teaching staff members are systematically collected by questionnaires (s. Standard 2.1, 2.2). Feedback of employers is collected in meetings with the Advisory Board. However, results are neither publicly available nor presented to the ET.	
Standard 2.7. Results of the internal quality assurance system are taken into account for further development of the study program. This includes evaluation results, investigation of the student workload, academic success and employment of graduates.	A
The SER states that FAV provides an annual internal self-evaluation report through the collection of information from the staff in relation to quality in teaching, learning,

student engagement in practical teaching, seminar work, extra-curricular learning, and participation in mobility.

The discussions with graduates and employers during the on-site visit showed that the study programs are well matched to the labour market. Further information on the employability of the graduates should be provided.

Standard 2.8. The institution ensures that reports on the overall quality of the A program are prepared periodically (eg. every three years) for consideration within the institution indicating its strengths and weaknesses.

Annual self-evaluation reports are prepared by FAV (s. Standard 2.7). SWOT analysis is included in the SERs.

Standard 2.9. The quality assurance arrangements for the program are themselves A regularly evaluated and improved.

The quality assurance processes are regularly evaluated by the KAA and updated according to KAA requirements. The ET trusts that the OFQA is monitored by the UP management.

SER contains Table 4. entitled <i>List of permanent academic staff at the Faculty of Agriculture and Veterinary</i> (either with unlimited or temporary contracts). As a supportive document the CVs of the 15 professors, all with the title of PhD, were submitted. In addition, SER points out that the professor's workload and engagement are presented in the course syllabus. However, the same table should be supported by teaching and research workload as well as the duration of thecontract. During the session meetings teaching staff reported that regular competition procedures become applied, including provision of full position descriptions and conditions of employment.	
 Standard 3.2. The teaching staff must comply with the legal requirements concerning the occupation of teaching positions included in the Administrative instruction on Accreditation. As stated in SER, each representative of the teaching staff complies with the legal requirements concerning the occupation of teaching positions included in the Administrative instruction on the Administrative instruction on Accreditation. This is also documented online through the online staff form available by KAA for those teaching staff members, engaged at the MSc study programs. 	A
Standard 3.3. Academic staff do not cover, within an academic year, more than two teaching positions (one full-time, one part-time), regardless of the educational institution where they carry out their activity.	A

According to SER academic staff has a primary job lecturing at the Faculty of Agriculture and Veterinary. This was confirmed during the meeting session dedicated to teaching stuff and as stated by SER can be verified through the online staff form available by KAA.	
Standard 3.4. At least 50% of the academic staff in the study program are full time employees, and account for at least 50% of the classes of the study program.According to SER, significantly more than 50% of the academic staff of the study	A
program are full-time employees and perform for more than 50% of the classes of the study program.	
Standard 3.5. For each student group (defined by the statute of the institution) and for every 60 ECTS credits in the study program, the institution has employed at least one full time staff with PhD title or equivalent title in the case of artistic/applied science institutions. The SER states that the criteria of Standard 3.5 are met as at the Department of FTBT there are currently 4 Doctors of Science (<i>Dr. Sc.</i>), from the field of food technology, and 18 Doctors of Science are with regular full-time contracts.Table 5.,with the names of four members of the Department of FTBT is provided in SER, however, their role in the terms of responsibility should be indicated.	В
Standard 3.6. Opportunities are provided for additional professional development of teaching staff, with special assistance given to any who are facing difficulties. The SER states that the professional development of teaching staff members is continuously supported through mobilities and participation at different conferences without providing details regarding the organization of specific events. Teaching staff members participated in various trainings as presented in their CVs in the Appendix. During the session meeting, teaching staff members mentioned workshops organized by the Centre for Excellence in Teaching of the University of Prishtina as well as the collaboration with Iowa University. SER highlights the increase in the budget of financed projects, and ET highly recommends that this trend continues in the future. The evidence of trainings i.e. certificates (time, place, organisation details) should be presented in future evaluations for each member of academic staff who attended the education as presented in the CV	В

Standard 3.7. The responsibilities of all teaching staff, especially full-time, include the engagement in the academic community, availability for consultations with students and community service.	A
The SER states that the teaching staff is engaged in student consultations and community service. This was also confirmed during the site visit meeting.	
Standard 3.8. Academic staff evaluation is conducted regularly at least through self-evaluation, students, peer and superiors' evaluations, and occur on a formal basis at least once each year. The results of the evaluation are made publicly available	В
According to SER, academic staff evaluation assessments, and evaluations of students, peers, and superiors are carried out every year through the established SEMS platform, however, examples of questionnaire analysis are not provided, except for a certain analysis of questionnaire in Albanian related to module and teaching staff evaluation by students. No other information regarding peer and supervisor evaluations is discussed in SER. SER states that the results are visible to the faculty management but are not made publicly available.	
Standard 3.9. Strategies for quality enhancement include improving the teaching strategies and quality of learning materials. The strategy and procedures for improving the quality of teaching and learning materials are not presented in the SER.	С

Standard 4.1. The study program is modelled on qualification objectives. These include subject-related and interdisciplinary aspects as well as the acquisition of disciplinary, methodological and generic skills and competencies. The aspects refer especially to academic or artistic competencies, to the capability of taking up adequate employment, contributing to the civil society and of developing the students' personality.	
The Learning outcomes of the program are clearly stated and indeed include different subject-related and interdisciplinary aspects. Additionally, the study program has clearly employment-oriented qualification objectives.	
Standard 4.2. The study program complies with the National Qualifications Framework and the Framework for Qualifications of the European Higher Education Area. The individual components of the program are combined in a way to best achieve the specified qualification objectives and provide for adequate forms of teaching and learning.	Α
As mentioned in the SER the study program is in compliance with the European Qualifications Framework for Higher Education Area and the National Qualifications Framework, according to which this study program belongs to its 7th level, which

includes the preparation of students for such levels of study. Also, this field of study is also in compliance with Erasmus Subject Area Codes (ESAC) points 01.3.	
Standard 4.3. The disciplines within the curriculum are provided in a logical flow and meet the definition and precise determination of the general and specific competencies, as well as the compatibility with the study programs and curricula delivered in the EHEA. To be listed at least 7 learning outcomes for the study program under evaluation.	В
The learning outcomes of the program are clearly provided in the SER. The structure of the program and the order of the courses are in certain cases confusing. For example it would be more beneficial to move the course Structural properties of food to the first semester and the one in Sensory evaluation in the second since it is required to have a solid background in food structuring in order to grasp the impact that these properties have in sensory analysis. Moreover the presence of a course in 'Technology of meat and meat products II' is not valid since part I is not offered in the MSc level. It could be renamed to 'Advanced topics in Technology of meat and meat products'. In that respect the titles and the order of the courses should be revised.	
Standard 4.4. The disciplines within the curriculum have analytical syllabuses which comprise at least the following: the discipline's objectives, the basic thematic content, learning outcomes, the distribution of classes, seminars and applicative activities, students' assessment system, the minimal bibliography, etc. The full course description/ syllabuses of each subject/ module should be attached only in electronic form to the self-assessment report for the study program under evaluation.	В
All required course information is provided in a well-arranged format in the syllabus found in Annex of the SER, comprising course objectives, learning outcomes, thematic content, teaching methods, students' assessment system and bibliography. However, the format of the descriptors is not homogeneous. The number of the learning objectives for each course of 5 ECTS should range between 4-6. More importantly the verbs that are used are not always appropriate for level 7. In Level 7 students are expected to develop analytical skills and critical thinking so the use of verbs such as describe, list etc should be avoided.

 Standard 4.5. If the language of instruction is other than Albanian, actions are taken to ensure that language skills of both students and academic staff are adequate for instruction in that language when students begin their studies. This may be done through language training prior to the commencement of the program. The official language of instruction is Albanian. However, it is mentioned in the SER that for interested students courses in English can be provided as well. Based on our visit, it seems that this can only be applied for the dissertation since not all faculty and students are proficient in the use of English 	В
 Standard 4.6. The student-teacher relationship is a partnership in which each assumes the responsibility of reaching the learning outcomes. Learning outcomes are explained and discussed with students from the perspective of their relevance to the students' development. In the SER it is mentioned that learning outcomes are described in the syllabi of the courses and they are applied throughout the semester. Moreover, the obligations of students and professors are discussed continuously, thus fulfilling the ongoing assessment. Indeed, the visit allowed us to see the continuous support of the teaching team to the students 	A
Standard 4.7. Teaching strategies are fit for the different types of learning outcomes programs are intended to develop. Strategies of teaching and assessment set out in program and course specifications are followed with flexibility to meet the needs of different groups of students. As described in the provided syllabus a variety of assessment methods are used and they are well defined.	Α
Standard 4.8. Student assessment mechanisms are conducted fairly and objectively, are appropriate for the different forms of learning sought and are clearly communicated to students at the beginning of courses. As stated in the SER Evaluation mechanisms are based on the Bologna Charter. and the communication with students in done via the SEMS platform.	A

 Standard 4.9. Appropriate, valid and reliable mechanisms are used for verifying standards of student achievement. The standard of work required for different grades is consistent over time, comparable in courses offered within a program, and in comparison with other study programs at highly regarded institutions. A stated in the SER the student grading system is determined on the basis of Article 109 of the Statute of the University "Hasan Prishtina" and is offered in this form: 10 and 9 (excellent); 8 (very good); 7 (good); 6 (enough); 5 (insufficient). The workload required to achieve a passing grade is consistent, as grades in this study program are evaluated and are built throughout the semester and as such are applied within subject syllabi. 	A
Standard 4.10. Policies and procedures include actions to be taken in to dealing with situations where standards of student achievement are inadequate or inconsistently assessed. The SER describes the procedure of repeating failed exams and refers to Section 115	В
of the Statute of the University of Pristina. However, since standard 4.10 also refers to the approved procedures that students should follow when they want to appeal to inadequate or inconsistent assessment the SER should refer to Section 114 as well.	
Standard 4.11. If the study program includes practice stages, the intended student learning outcomes are clearly specified and effective processes are followed to ensure that those learning outcomes and the strategies to develop that learning are understood by students. The practice stages are allocated ETCS credits and the work of the students at the practical training organisations is monitored through activity reports; students during practice stages have assigned tutors among the academic staff in the study program.	В
In this program the internship is an elective course and is awarded with 5 ECTS. Upon completion the students should submit a report.	
Standard 4.12. In order to facilitate the practice stages, the higher education institution signs cooperation agreements, contracts or other documents with institutions/organisations/practical training units.	Α

This is an excellent practice and the list provided is lengthy to support the existing number of students.

Compliance level: Substantially compliant **ET Recommendations:**

- Revision of course descriptors regarding the titles, the number and the levelness of learning outcomes. It is suggested to use the BLOOM taxonomy in order to use the appropriate wording for level 7.
- Presentation of the bibliography in a consistent form and addition of the DOI number to the readings.
- Increase of the number of ECTS for the Practical work/Internship course to a minimum of 12 instead of 5. Additionally, there should be official and direct involvement of an Academic supervisor to the project in order to reassure the standards that are required for a level 7 student are met.
- Since nowadays the use of AI is increasing it is recommended to increase the number of oral presentation as a means of assessment in order to enhance students soft skills and critical thinking a well as to indirectly evaluate the originality of the work.

The public call for new academic year enrolment contains this obligatory condition which is confirmed visiting the UP's web site.

The previous Re-accreditation Expert Team's Report approved the MSc study programme of Food Science with no more than 40 students' enrolments in 1 st year. The Table 11 of the SER (p. 38) presents number of registered students at MSc level

in five FAV's study programmes. The total number of the students enrolled to both study years in the past three years of the MSC Food Technology is 2020/21:77; 2021/22: 100; 2022/23: 82. The FAV with the SER (p.40) applies for 30 new enrolments while the First page of the SER contains information of 20 current places for MSc enrolment. There is no information on the dropout rate. The building and the laboratories are not in good condition and assumably can not accommodate large groups of students.	
 Standard 5.4. Feedback to students on their performance and results of assessments is given promptly and accompanied by mechanisms for assistance if needed. According to the Statute of the UP (2022) Article 110: Examinations shall serve as the regular mode of evaluation of knowledge. The procedure of delivery of an 	A
examination is defined by the study program. The mode of determining the knowledge and passing the exam shall be defined by the course syllabus. The study programme syllabi have defined fashion of examination. The SER (p.38) claims that the students can participate in the exams three times per academic year. The feedback is provided soon after the exams. The assistance is in a form of consultation meetings with the teachers available twice per week, yet there is no record about it. There is available mechanism for complaints. In case of dissatisfaction students can take exam in front of a special commission.	
Standard 5.5. The results obtained by the students throughout the study cycles are certified by the academic record.	А
The UP Statute, Article 231 defines: the General Secretary of the UP keeps the records of the following: applicants for admission; students enrolled for all programs of study and scientific research; graduates; staff under contract; property; financial accounts; research, artistic, and consultancy projects; commercial contracts; academic work performance reports; evaluations; other matters as required by the Steering Council, the Rector, or the Senate. The support mentioned as flexible treatment of students in special situations is three examinations period (SER, p. 38-39), while the Regulation nor any other document does not contain other types of special conditions except for the exams. The ET considers that UP should improve its strategy into support students in special situations. No records have been provided on how often students apply, for what reason and what is the percentage of the approval. It is possible that there is a non-formal procedure in application for individual cases, but there is no evidence about it.	
Standard 5.7. Records of student completion rates are kept for all courses and for the program as a whole and included among quality indicators.	В
According to the information provided, there are processes in place to collect and analyse data referring to the student progression and drop-out rates. The institution collects also data on students' satisfaction with their programmes, the learning resources, and administration and support services. The ET considers that the FAV and the study program will continue the process and provide the evidences about student performance monitoring implementation.	
Standard 5.8. Effective procedures are being used to ensure that work submitted by students is original.	С
The UP established different regulations to deal with academic misconduct, including plagiarism and other forms of cheating. In March 2021, the University adopted the Regulation on the procedure and disciplinary phases against students' misbehaviour that is, among other things, the ground for the plagiarism monitoring and prevention. There are no clear evidence of anti-plagiarism check system of the students works. The supervisors and the Committee in front of whom the student defends their thesis are the only control mechanism against plagiarism in the students' texts. After the successful defend of their thesis it is uploaded to the UP website and through the SEMS, which is a step closer to combat against plagiarism. In that way, at least, the thesis will be more likely original when exposed to the public eye. The SER (p.39) poorly addresses this issue.	
Standard 5.9. Students' rights and obligations are made publicly available, promoted to all those concerned and enforced equitably; these will include the right to academic appeals.	A
The Statute of the University of Prishtina (Article 145) defines clearly student rights and obligations. The document is publicly available.

The evaluation process has confirmed the presence of information, outside the documents supplied in advance of the visit, that demonstrate institution-wide arrangements for student admissions, rights of representation, student's transfer, student feedback via 'satisfaction surveys', complaint procedures and similar. There is an established mechanism for students' rights ensured

Based on the Statute, the Regulation and the Code of Ethics, the FAV continually shows the rights and obligations of the students. In certain situations, students also use the legal opportunity for academic appeals, respectively, to undergo a specific examination before the members of the commissions set by the academic unit. The rights and obligations of students are made available to the public, promoted to all interested parties, and applied equally; this will include the right to academic appeals. Student rights and obligations are publicly available and equally enforced. Regarding student complaints, there are two levels: the first level is FAV and the second level is UP. Both institutions comply with the Code of Ethics (2013) and the recently adopted Regulation on Procedures and disciplinary phases against student Misbehaviour (2021) presided over by the Ethics Council and the Disciplinary Committee. In addition, there is a student union that provides several services for gathering student rights, such as student elections for participation in decision-making processes, filing complaints, and the like. The union organizes elections of student representatives for participation in decision-making through participation in various committees of faculties and study programmes.

The Expert team confirms the standard criterium is met.

Standard 5.10. The students' transfer between higher education institutions, faculties A and study programs is clearly regulated in formal internal documents. Regarding the student mobility, the University Regulation on the student transfer and mobility in the University of Hasan Prishtina (2017) clearly describes available possibilities and procedures.

According to the SER (P.39) The transfer of students between higher education institutions, faculties and study programs is regulated at university level, with Regulation 2/111 of 14.7.2017, which is public on the University web site.

Standard 5.11. Academic staff is available at sufficient scheduled times for B consultation and advice to students. Adequate tutorial assistance is provided to ensure understanding and ability to apply learning.

The SER (p.39) explicits that the academic staff publishes materials and information related to the teaching process also in the Electronic Management System for Students SEMS. During the interviews it has been confirmed that the academic staff is obligated to publish the consultation schedule at least twice a week. However, these

consultations are going on daily and the number of students requesting a meeting is relatively large. There is no data about consultation hours. The mentoring system peer-to-peer does not exist.

Overall

Compliance level: Substantially compliant

ET recommendations:

- 1. The SER should contain sufficient and specific data for assessment of the study programme according to the standards. The SER lacks Key Performance Indicators (KPIs) such as number of student enrolment to each year, number of graduates per academic year, retention rates, number of dropouts, average duration of the studying, mobility participation and similar. For the next re-accreditation KPIs should be presented with clearly set threshold indicators and their achievement.
- 2. The recommendation regarding high drop-out of the study programmes' students is for the Faculty to develop the support system that will reduce the unwillingness of the enrolled students to finish their study.
- 3. Students don't have feedback on their comments in the student survey. The faculty should take the responsibility for disseminating the questionnaire results with the suggestions for the improvement.

In the SER research objectives are not explicitly defined. However, the Senate of the	
UP, considers the number of scientific articles in refereed international journals as a	
main criterion for the promotion of academic staff. During the visit, the academic	
staff were aware of the importance of research for the development of the FAV and	
their own career. Some funds are given by UP and the FAV for research. Greater	
efforts could still be made. As clearly satted in the SER Financial and logistical	
support for research in this program is lacking. However, the policies for promoting

In the SER, it is stated that involvement of teaching staff in research activities and their performance in relation to academic promotion are specified in regulation no. 465, dated 02.03.2018 of the University of Prishtina "Hasan Prishtina" and Administrative Instruction 1/2018 of the Ministry of Education Science and Technology for the recognition of international publication platforms and journals. During the visit, the teaching staff clearly states to the ET that they were aware of the importance of research activities in their evaluation and promotion and consider that the mechanism is transparent. The teaching load appears for some of them a little high at the expense of the research.

Standard 6.3. Clear policies are established for defining what is recognized as A research, consistent with international standards and established norms in the field of study of the program.

According to the SER "clear policies are specified in regulation no. 465, dated 03.02.2018 of the University of Prishtina "Hasan Prishtina" and Administrative

In terms of infrastructure, FAV is in a critical, ongoing exceptional situation. Lectures are currently being temporarily relocated to the building of a mathematical secondary school, as the former building is being converted for other purposes and the new building is not ready for occupancy. Due to official safety requirements, modifications to the building are necessary. FAV expects the building to be completed and ready for occupation by September 2024. However, the ET cannot evaluate the standard on the basis of expected future conditions, but solely on the basis of the actual situation as it was found on February 28 and 29, 2024 during the site visit.

However, it is indicated in the SER and confirmed during the site visit that budget allocated is sufficient for delivering the study program. Standard 7.3. The higher education institution must demonstrate with adequate В documents (property deeds, lease contracts, inventories, invoices etc.) that, for the study program submitted for evaluation it possesses the following, for the next at least three years: *a)* owned or rented spaces adequate for the educational process; s. It is not confirmed yet whether FAV still has its own library and where this currently is accommodated. As mentioned by the students at the meetings, there are sufficient desk places in the library for concentrated learning. Standard 7.4. The number of seats in the lecture rooms, seminar rooms and D

3. OVERALL EVALUATION AND RECOMMENDATION OF THE ET

In conclusion, the Expert Team considers that the study program *M.Sc. Food Science* offered by the University of Prishtina "Hasan Prishtina", Faculty of Agriculture and Veterinary is *substantially compliant* with Standards 1-6, but *non-compliant* with Standard 7 (Infrastructure and resources) as included in the *KAA Accreditation manual* and, therefore, recommends *not to accredit* the study program before the new premises are completed and occupied.
