**1. Approval of agenda**

The SCQ unanimously approved the agenda.

**2. Approval of minutes from SCQ 138**

The SCQ unanimously approved the minutes.

**3. Revision of expert reports for institutional and program accreditation**

**3.1. RIT Kosovo (AUK)** – The Board unanimously approved the expert report, granting institutional accreditation for a period of five (5) years.

**3.2. UBT College Traffic and Transport Engineering, MSc** – The expert report was unanimously approved for a period of three (3) years with a student quota of 35.

**3.3. UBT Dramatic Arts, BP** - The expert report was unanimously approved for a period of three (3) years with a student quota of 30.

**3.4. UIB Mitrovicë Mineral Deposits, MSc** – The expert report was postponed. The SCQ requested that the external experts specify the student quota on an annual basis, rather than for a two-year period.

**3.5. UFA Gjakovë Albanian Language and Literature, BA** – The expert report was unanimously approved for a period of three (3) years with a student quota of 40.

**3.6. UP Artet Visual Arts, BA (with 6 specializations)** – The expert report was unanimously approved for a period of five (5) years with a student quota of 100.

**3.7. UP Artet Visual Arts, MA (with 6 specializations)** – The expert report was unanimously approved for a period of five (5) years with a student quota of 100.

**3.8. UP Artet Master of Music in Performance (with 5 specializations), MMus** - The expert report was unanimously approved for a period of three (3) years with a student quota of 25 in accordance with the fulfillment of the recommendations.

**3.9. UP Artet Master of Music in Composition with specialization in Composition, Mmus**  
The expert report was unanimously approved for a period of three (3) years with a student quota of 4 in accordance with the fulfillment of the recommendations.

**3.10. UHZ Peja Business and Economics, PhD** – The expert report was unanimously approved for a period of three (3) years with a student quota of 9.

**3.11. Rezonanca Biochemistry Laboratory, BSc** – The expert report was unanimously approved for a period of three (3) years with a student quota of 50.

**3.12. UP Artet Bachelor of Music (with 2 specializations), BMus** – The expert report was unanimously approved for a period of three (3) years with a student quota of 25 in accordance with the fulfillment of the recommendations.

**3.13. AAB College General Law, LLB** – The expert report was unanimously approved for a period of five (5) years with a student quota of 250.

**3.14. UKZ Gjilan General Law, LLB** – The SCQ unanimously approved the expert report recommending not to grant accreditation.

**3.15. UKZ Gjilan Criminal Law, LLM** - The SCQ unanimously approved the expert report recommending not to grant accreditation.

4. **Regulation Standards for evaluation of Doctoral Programs** – The SCQ reviewed the feedback received from higher education institutions and incorporated the necessary amendments into the draft regulation. The revised version was unanimously approved by the SCQ. It was also noted that these standards do not apply to doctoral programs in the arts, joint degree programs, or dual degree programs. The document was approved as the final version of the regulation.
5. **Regulation on Monitoring and Post-accreditation procedure** – The SCQ reviewed comments submitted by higher education institutions as well as input from the KAA Department of Monitoring and Post-Accreditation Procedures. Based on the feedback received, the necessary revisions were made to the draft regulation. The proposed changes were unanimously approved. It was also noted that the KAA should formally inform the respective institution of the monitoring report following the completion of the monitoring visit. The regulation was unanimously approved as the final version.
6. **Appeals**
  - 6.1. **University of Gjakova** – The appeal review was postponed to the next meeting. The KAA administration was instructed to request the institution to provide a translation of at least the first page of the appeal in both English and Albanian. Due to time constraints, it was unanimously agreed that the appeal will be voted on via email once the English version of the document is received.
